



SCHEDULE OF FEES FOR SERVICES

2024-2025 SCHOOL YEAR

In an effort to help clarify our fee schedule; below is a detailed explanation of our payment procedures.

The school calendar year consists of 180 days that the children are in attendance. Each month varies from another in the amount of days attended. Due to the variance, we have broken up the extended day fees into 10 equal payments for your convenience. Each payment covers 18 days of child care. Florida state law requires that all services must be paid in full prior to services being rendered.

Due to state law and regulation payments will be **due on the 15th of the month**. All payments past due by 5 days will be rendered a \$5.00 late fee and \$5.00 fee per every 5 days late after that. (i.e. late fees will be assessed on the 20th, 25th, 30th, etc.)

If balance is unpaid by the date in the "Payment Covers Care Through:" box below, your child will be unable to attend Extended Day until balance is paid in full, including any late fees that have been assessed to the account.
